UPDATED COVID-19 GUIDELINES

To prevent or slow the spread of Coronavirus Disease 2019 (COVID-19), the City of Brevig Mission has established the following guidelines:

There will be no inter-village travel or visiting, if you must travel for medical, subsistence and essential needs at the hours listed on Trooper outpost, can provide you with a COVID-19 test.

ALL individuals who are traveling will be met at the Brevig Mission Airport by the COVID-19 Mitigators, who will confirm and document their date of entry, their vaccination status and their quarantine duration.

Violation(s) of these rules may result with any such fines, in the City of Brevig Mission Lock down notice. Any individual coming into Brevig Mission must show documentation providing a negative test result 1-3 days prior and must be sent to the City of Brevig Mission through fax number-1-907-642-2194 or send to either email listed below:

All individuals are now required to use a face mask, covering both the mouth and nose in all public places.

Residential travel is permitted into the City of Brevig Mission for:

- Residents returning from medical appointments and or emergencies.
- Residents who provide documentation of a negative COVID-19 test result, **1-3 days prior** to entering the community of Brevig Mission.
- Residents that have the symptoms of cough and/or fever of 100.4 or higher **must** call the Brevig Mission Clinic to make an appointment to be seen.
- Residents are encouraged to maintain social distancing, extending your distance to any individual of at least 6 feet apart in all public meetings.

ALL Essential travel is permitted for those who complies with the following:

- Outside personnel for essential work that are to respond to the community emergencies.
- Providing the City of Brevig Mission COVID-19 test result.

Vaccinated/Unvaccinated-Vaccinated people who traveled from Anchorage needs to quarantine for 1 week.
Unvaccinated people who traveled from Anchorage need to quarantine for 10 days.

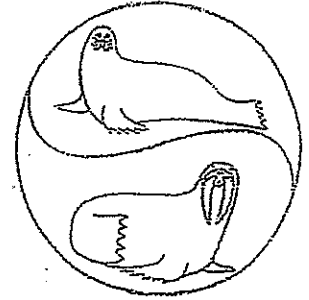

We need every one of us to follow guidelines listed below, the more we cooperate and follow these guidelines, the quicker we can end this order and return to normalcy.

Here are the guidelines

INTERVILLAGE TRAVEL

- Travel with a prior negative covid-19 test for medical, subsistence and essential needs is allowed, Violation of these travel rules will be met with these fines.

1st offense \$25
 2nd offense \$50
 3rd offense \$75
 4th offense will increase by \$100 and so forth.

CURFEW

- Nightly curfew lasts from 10:00 PM – 7:00AM. There will be no inter-village travel or visiting, if you must travel for medical, subsistence and essential needs at these hours the trooper’s outpost can provide u with a covid-19 test. Violations of these curfew rules will be met with these fines.

1st offense - \$25
 2nd offense - \$50
 3rd offense - \$75
 4th offense will increase by \$100 and so forth.

MASK’S

- Masks violations will be met with these fines

1st offense - \$ 25
 2nd offense - \$ 50
 3rd offense - \$ 100
 4TH offense will increase by \$100 and so forth
