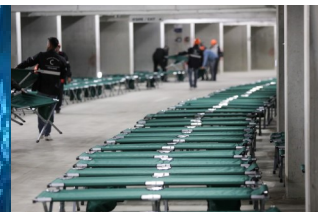

 - In addition to amounts already available in subsection 402(A) of the CARES Act; appropriation of \$1,320,000,000 for FY2020 for supplemental awards for the detection, of SARS-CoV-2 or the prevention, diagnosis, and treatment of COVID-19.
 - Funds for programs authorized under sections 330-340 of the Public Health Service Act. (42 CFR 254-256) <https://www.law.cornell.edu/uscode/text/42/chapter-6A/subchapter-II/part-D>
 - **Sec. 4213. Telehealth Network and Telehealth Resource Centers Grant Programs.** Amendments for Section 330I of the Public Health Service Act 42 CFR 254C-14) Provides

 - Program expanded from 4-5 years.
 - Focus on projects that are regional in nature.

Health Funding Fact Sheet

Overview

The Coronavirus Aid, Relief, and Economic Security Act (CARES Act 2020) was signed into law on March 27, 2020. The Act focuses on stimulating the economy, addressing healthcare services, addressing revenue losses, and increasing allocations to certain grant programs. Of particular interest are programs to be administered by Health and Human Services available to state and local entities and healthcare providers to enhance their abilities to provide services for those impacted by SARS-CoV-2 and the disease it causes known as COVID-19.

The Act also addresses:

- ✓ Updates to the medical supplies in the Strategic National Stockpile
- ✓ Preventing essential medical device shortages
- ✓ Access to COVID-19 testing and care services
- ✓ The use of HIPAA information during a public health emergency
- ✓ Provision of nutritional services to people who have been quarantined or are otherwise homebound by reason of illness.

Highlighted Programs

- ✓ \$1,320,000,000 in FY2020 for supplemental awards for Community Health Centers focused on the prevention, diagnosis, and treatment of COVID-19.
- ✓ \$29,000,000 each year FY2021—FY2025 for grants under the Telehealth Network and Telehealth Resource Center Grants Program.
- ✓ \$79,500,000 each year FY2021—FY2025 for the Rural Health Care Services Outreach, Rural Health Network, and Small Health Care Provider Quality Improvement Grant Programs.
- ✓ \$1,500,000,000 for grants and cooperative agreements under the CDC-Wide Activities Program Support.
- ✓ \$250,000,000 available for grants and cooperatives agreements under the Hospital Preparedness Program.
- ✓ \$100,000,000,000 for grants or other mechanisms for eligible health care providers for health care-related expenses or lost revenues attributed to coronavirus.

CDBG Infectious Disease Response



Fact Sheet

Overview

The Community Development Block Grant (CDBG) Program provides annual grants on a formula basis to states, cities, and counties to support development of viable urban communities by providing decent housing and a suitable living environment and by expanding economic opportunities principally for low- and moderate-income persons. CDBG Infectious Disease Response allows grantees to use CDBG funds for a range of eligible activities to prevent and respond to the spread of COVID-19.

Quick Facts

- ✓ Administered by HUD under the existing CDBG program.
- ✓ Grantees are able to reallocate current grant funds by amending their Consolidated Annual Action Plan.
- ✓ Grantees must amend their Consolidated Annual Action Plan if there is a change to the allocation priorities or method of distribution of funds.
- ✓ If changes meet the criteria for a “substantial amendment” in the grantee’s Citizen Participation Plan, the grantee must follow its citizen participation process for amendments.
- ✓ Costs are covered 100% (no split).
- ✓ Grantees must coordinate with their local public health officials before undertaking any activity to support state or local pandemic response.

Eligible Activities

- ✓ Establish, stabilize, and expand microenterprises that provide medical, food delivery, cleaning, and other services to support home health and quarantine.
- ✓ Increase the capacity and availability of targeted health services for infectious disease response within existing health facilities.
- ✓ Deliver meals on wheels to quarantined individuals or to individuals who need to maintain social distancing due to medical vulnerabilities.
- ✓ States Only: Planning Grants—Grant funds may be used for planning activities in conjunction with an approved program activity; they may also be used for planning only as an activity. These activities must meet or demonstrate that they would meet a national objective. These activities are subject to the State’s 20% administration, planning, and technical assistance cap.

Community Disaster Loan Program



Fact Sheet

Overview

The Community Disaster Loan (CDL) Program provides operational funding to help local governments that have incurred a significant loss in revenue due to a major disaster, and the loss in revenue has or will adversely affect the government's ability to provide essential municipal services. The program falls under the Stafford Act which authorizes FEMA to provide direct loans to local governments who have suffered a substantial loss as a result of a Major Disaster Presidential declaration. *At this time the program has not been activated, but it is anticipated that it will be as the COVID-19 public health emergency continues to impact the economy.*

Quick Facts

- ✓ Program is administered by FEMA and falls under Subpart K of the Stafford Act.
- ✓ State must have been granted a Major Disaster Presidential Declaration for localities to be eligible.
- ✓ The Governor's Authorized Representative must request activation of the CDL Program for the specific disaster.
- ✓ Loans are available for up to 25% of the annual operating budget of the locality, up to \$5 million, and amounts are determined by the economic impact to the jurisdiction.
- ✓ No cost split as this is a direct loan to the local jurisdiction.
- ✓ Local governments must be able to show a substantial loss (greater than 5% of the tax and other revenues for the current or succeeding year as a result of a major disaster).
- ✓ The local government entity cannot be in arrears with respect to any payments due on previous loans.
- ✓ Application period begins on the last day of the disaster incident period as declared by the President through the end of the local government's subsequent fiscal year.
- ✓ The term of the loan is for 5 years and can be extended to 10 years, with an Applicant selected payment schedule.
- ✓ Interest accrues only on the portion of the funds drawn down by the applicant.
- ✓ Starting on the second year, and for the life of the loan, the local government must provide audited financial statements to FEMA to assess current need for continued disbursements.
- ✓ The loan may be cancelled if the local government can show it has a cumulative operating deficit.

Eligible Activities

- ✓ Funds must be used to cover immediate needs to continue providing essential municipal services or to expand existing municipal services to meet disaster-related needs.

Overview

The Federal Transit Administration (FTA) is allocating \$25 billion to recipients of urbanized area and rural area formula funds, with \$22.7 billion allocated to large and small urban areas and \$2.2 billion allocated to rural areas. Funding will be provided at a 100% federal share, with no local match required, and will be available to support capital, operating, and other expenses generally eligible under those programs to prevent, prepare for, and respond to COVID-19.

Grant funds are also available to cover COVID-19 capital and operating expenses incurred on or after January 20, 2020 including operating expenses to maintain transit services as well as the cost of administrative leave for transit personnel due to reduced operations during an emergency.

Quick Facts

- ✓ \$25,000,000,000 in grant funds available.
- ✓ Federal share for all CAREs Act grants is 100% with no local match required.
- ✓ Transit agencies are eligible to receive funds in states where the Governor has declared an emergency in response to the COVID-19 public health emergency.
- ✓ Transit programs must request a waiver through their regular grant formula programs to utilize the funds.
- ✓ Federal procurement standards can be waived due to the exigent circumstances.
- ✓ Funds are available until expended.

- ✓ Performing enhanced cleaning/sanitizing of rolling stock, stations, bus shelters, etc.
- ✓ Decontamination of facilities and transit vehicles.
- ✓ Placing hand sanitizer dispensers in high traffic areas.
- ✓ Providing personal protective equipment (PPE) as appropriate.
- ✓ Extending current cleaning contracts as needed.
- ✓ Supporting capital, operating, and other expenses generally eligible under those programs to prevent, prepare for, and respond to COVID-19. This includes up to an 80% federal share of capital and operating expenses incurred beginning on January 20, 2020 for all rural and urban recipients, including operating expenses to maintain transit services, as well as, the cost of administrative leave for transit personnel due to reduced operations during an emergency.
