## Elim COVID-19

The Native Village of Elim (NVE), Elim Native Corporation (ENC) and the City of Elim (COE) have come together with one goal in mind. Our goal is to reduce the entrance and spread of COVID-

## EFFECTIVE: MARCH 25, 2020 AT 11:59PM

There will be no passenger transportation in and out of the village until May 1, 2020. Residents wishing to return home should do so immediately with a MANDATORY TWO WEEK QUARANTINE upon return.

Local agencies will reevaluate the ban three weeks later on April 15, 2020; with no positive cases, we will consider moving to a highly restrictive travel ban

## The following are exceptions to the travel ban:

- 1. Essential personnel for emergencies (i.e. electricity, water or sewer repairs) with a screening by a travel committee consisting of NVE, COE, and ENC elected members.
- 2. Essential medical travel and freight:
  - a. Norton Sound Health Corporation (NSHC) will need to get important medical supplies in and out of Elim.
  - b. Patients will need to travel in and out of Elim.
  - c. NSHC medical providers will need to travel in and out of Elim; however, all NSHC medical providers must go through a two-week quarantine prior to coming to Elim.
- 3. Freight, cargo and mail servicus are still permitted. Flight crews are asked to stay in aircraft if possible. However, they may conduct any necessary business required by their job or use the bathroom if needed. No local pricargo handlers are allowed on board the

NVE, COE and ENC asks our community members to please be safe and please follow selfquarantine guidelines and social distancing to slow the spread of COVID-19.

Anyone who has traveled to Elim from OUT OF REGION in the past 14 days must self quarantine until 14 days from the date of travel.

- No large gatherings (10 or more people) will be permitted in the community with further notice; must stay 6 (six) feet away from others for any small gatherings.
- Residents are encouraged to limit visitation to other homes and no loitering in public places.
- Residents should avoid going to the clinic if they are not sick.
- Residents who have symptoms of cough and temperature of 100.4 or higher MUST call the nurse triage line 1-844-586-8773 or 443-6411 to make an appointment to be seen.
- Follow NSHC Elim Clinic protocols.
- No Out-of-town shopping at Elim Native Store.
- Quarantine buildings: Kawerak Early Childhood Education (ECE) Building and Armory.
- Practice good hygiene-wash your hands with soap and water for 20 seconds, use hand sanitizer if no spap/water is available. Wipe down frequently touched surfaces (door knots, sink handles, phones, countertops, keyboards, etc.) DON'T TOUCH YOUR FACE!
