Upon returning to the City of Gambell, the individual(s) are to:

- 1. Shelter in Place

- 3. Work from home as much as possible
- 4. Immediately isolate from members who are ill or sick
- 5. Refrain from public/private gatherings
- 6. State and local Law Enforcement are authorized to enforce individual compliance, Violators risk both Civil and Criminal Prosecution.
