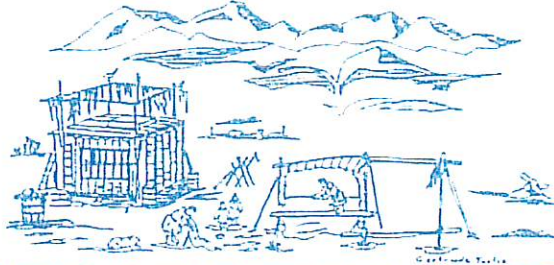

## TRIBAL ENROLLMENT

Dear Applicant:

When requesting applications for tribal enrollment in the Native Village of Savoonga, there are a few things that one needs to understand. There are a lot of rules and regulations one must follow in this complicated procedure of enrollment.

1. You must have at least ¼ Native blood to be considered for enrollment.
2. BIOLOGICAL ancestry must be used. No questions asked. Adoptive parents' blood cannot be used to determine quantity of native blood. If you do not know a biological parent's name and/or they are not recorded on your original birth certificate, it will be assumed that the parent does not possess any native blood and will therefore count as having zero native blood. We are sorry for this inconvenience, but it is just beyond our control. Please try to understand. We are only trying to do our job to the best of our ability and as fair as possible.
3. You must NOT be tribally enrolled elsewhere. Dual membership is strictly prohibited. You, can however, be a shareholder elsewhere AND be a tribal member of Savoonga. Most people are not aware of the differences of tribal enrollment and being a shareholder in a corporation. The only thing we are concerned about is a dual tribal membership. *Example:* John Doe is a Bering Straits Native Corporation shareholder, this does not automatically disqualify him for tribal enrollment in Savoonga. However, if he is a member of Nome Eskimo Community, he is not eligible for tribal enrollment in Savoonga.
4. Relinquishment forms are available if one wishes to terminate his/her enrollment either in Savoonga or elsewhere. If you are enrolled elsewhere, but wish to be enrolled in Savoonga, you can fill out a relinquishment form from your tribal enrollment office and the application process for our enrollment can begin and vice versa.
5. You must include a copy of either an original birth certificate or certificate of baptism, social security card, and when applicable, marriage licenses or adoption records. Any and all other records with proof of identity will be gladly accepted as well.

There are other rules and regulations pertaining to tribal enrollment that are not mentioned above. There are just the basics that we would like for you to know about when first enrolling. Upon your decision to enroll, the other rules and regulations will be brought up when needed.

Once again, we would like to thank you in advance for your understanding of our position and limitations in the enrollment process and the rules and regulations that we must follow.
