Once received, we can prepare the actual Last Will & Testament document on your behalf, for your signature. Could you also send us your and your immediate family's Vital Record documents which would help us with any probate case that comes up in the future.

We will create a certificate copy and send back the original with your Last Will & Testament. We need Birth Certificate, Death Certificates, Marriage Certificates, Divorce Decrees, Adoption paperwork, Tribal enrollment documents, and/or Military Records.

#### UPON RECEIPT OF THE COMPLETED FORM, KAWERAK, INC., LAND MANAGEMENT SERVICES STAFF WILL:

- **I.** Take the information you list in this form and prepare your actual Last Will & Testament.
- II. Mail the Last Will & Testament to you for review.
- III. If you approve of the Last Will & Testament, then you and two witnesses (who will not inherit any of your property) must sign it in the presence of a notary public.

If you find any changes or corrections that LMS must make on your Last Will & Testament, contact the Kawerak LMS Staff Member that you are working with, and they will make changes/corrections per your direction.

You are also welcome to contact us to update/create a new Last Will and Testament at your discretion.
